Pursuant to the State's Motion for Entry of Default Judgment and good cause appearing, the Court makes the following findings of fact and enters the following orders:

Findings of Fact

1. Defendants are in default.

2 IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Default Judgment be
3 entered against Defendants Dependable Locks, Inc., Priceline Locksmith, A1 Locksmith 24 Hours, Inc.,
4 A1 24 HR Locksmith, David Sasson and Jane Doe Sasson, Gilad Gill and Jane Doe Gill, and David
5 Peer and Jane Doe Peer; and it is further

6 ORDERED, ADJUDGED, AND DECREED Defendants are permanently enjoined and
7 restrained from violating the Consumer Fraud Act, A.R.S. § 44-1521 *et seq.*, as it is currently written or
8 as may be amended in the future pursuant to A.R.S. § 44-1528(A); and it is further

10 ORDERED, ADJUDGED, AND DECREED Defendants are permanently enjoined and
11 restrained from conducting any business in, into, or from the State of Arizona, including any locksmith
12 business pursuant to A.R.S. § 44-1528(A); and it is further

13 ORDERED, ADJUDGED, AND DECREED that Plaintiff be awarded civil penalties in the
14 amount of \$70,000.00 pursuant A.R.S. § 44-1531(A); and it is further

15
16 ORDERED, ADJUDGED, AND DECREED that Plaintiff be awarded \$22,552.04 in attorney's
17 fees and costs pursuant to A.R.S. § 44-1534 and it is further

18 ORDERED, ADJUDGED, AND DECREED that nothing contained in this Judgment shall be
19 construed to deprive any consumer or other person or entity of any private right under the law; and it is
20 further

21 ORDERED, ADJUDGED, AND DECREED that jurisdiction is retained by this Court for the
22 purpose of enabling any of the parties to this proceeding to apply to this Court for any other such further
23 orders and directions as may be necessary and appropriate for the enforcement of, or compliance with,
24 this Judgment, and to grant such other relief as the Court may deem necessary and just.
