2017 case description follows:

David Draper, a locksmith from Winters, CA noticed that he wasn't getting the quantity of calls he should have been. Subsequently he was called by an ongoing customer who informed him that there was a "technician" at the customers' location telling him that he was Lockie Draper's son and that he had been sent because Mr. Draper had suffered a heart attack. Mr. Draper was able to determine that the "technician" was Robert Cantrell, who Mr. Draper had never sent on a job.

Mr. Draper contacted law enforcement and a report was made apparently citing a violation date and time of 04/28/2017 12:00 AM.

According to Superior Court records, as displayed on the web the timeline goes:

8/8/2017 - Bail Bond Posted.

11/14/2017 – Criminal Complaint filed – some notation of a "Late Filing" – Mr Cantrell was arraigned, pled not guilty, waived time and his bail was continued.

11/17/2017 – PHC – matter heard.

12/11/2017 – "170 Motion" was filed (Challenging the judge's ability to hear the case)

12/14/2017 – "PHC - "170.6 DENIED" set for court date 1/25/2017 @ 10AM in Department 11  
With judge Timothy Fall Presiding.
